Also, the work consists of top side and underdeck structural repairs; concrete fabriform slope protection repair and rip-rap shoreline stabilization, removal and replacement of an existing waterline; installation of new fire hydrant and potable water meter assemblies; new electrical lighting, conduit and wiring; and minor cut/fill with erosion and sedimentation controls, concrete paving, striping, fencing, guardrail and signage.
